NWEA hosts 2017 Water Environment Federation Collection Systems Conference, helps raise more than \$10,000 for two water-focused non-profits

The NWEA and the City of Omaha co-hosted the 2017 Water Environment Federation Collection Systems Conference on May 21-24, 2017 at the CenturyLink Center in Omaha. The conference drew approximately 550 attendees from more than 40 states, Canada, and Europe, as well as more than 50 exhibitors, including a sewer history exhibit sponsored by the National Association of Sewer Service Companies.

The conference began on Sunday, May 21, with two workshops focused on "Performance Management for Collection System O&M Programs" and "Managing Uncertainty: Program Management Concepts for I/I Control Programs." Both workshops included active participation from various individuals from Omaha Public Works and surrounding communities.

The workshops were followed by an evening social, sponsored by NWEA, at the Lauritzen Gardens. In addition to being one of the most beautiful places in Omaha, the Lauritzen Gardens was an ideal venue for the social it is also the site of a recently completed sewer separation project. More than 300 NWEA members and 2017 WEF

Conference attendees attended the social. As a result of fundraising and donations for the social, a donation of approximately \$5,500 was given to both Engineers Without Borders and Water for People.

The second day of the conference included:

- a summary of the Omaha Sewer History and the "Back to the River" initiative, provided by Jim Theiler of Omaha Public Works and Scott Aurit with the Nebraska Water Environment Association.
- an overview of the Henry Doorly Zoo and its amphibian conservation initiative, provided by Peter Brunette.
- a variety of vendor mobile sessions highlighting collection system technologies.
- 13 technical sessions providing a collective 52 presentations, including two local sessions that highlighted specific issues in the Nebraska/Iowa and Kansas/Missouri areas. The Nebraska presentations featured the Omaha CSO Control Program and green infrastructure in Omaha parks.

The final two days of the 2017 WEF Conference featured tours that allowed attendees to see improvements made to Omaha's collection system. The first tour was of the Leavenworth Lift Station, South Omaha Area Industrial Lift Station, and the Missouri River Wastewater Treatment Plant Improvements project. The second tour included Adams Park, Fontenelle Park, Saddle Creek Area Sewer Separation, Spring Lake Park, and the UNO Visitors Center bioretention basin.

Eileen J. O'Neill, Ph.D., who is the Executive Director of the Water Environment Federation said;

"Attendance exceeded budget, there was good participation of first-time attendance and a sense of energy at the event and actually in Omaha generally. The hospitality of our local hosts was simply outstanding and this certainly made the event extra special for those of us from out of town".
